



Amateur Boxing Alliance (England)

Sub Committees

The Amateur Boxing Alliance (England) CIC Management committee are advised by several sub committees who are dedicated to specific aspects within the sport of Amateur Boxing. The sub committees are made up from a nomination(s) from each of the Boxing Regions whom they consider to be experts within their fields and are ratified annually at the National AGM by the membership. The sub committees cannot implement rule changes or new processes but can recommend them to the Management committee and if approved, will follow due process for national implementation. The only exceptions to this would be issues of legality and Disciplinary matters.

The sub committees should consist of up to four volunteer members who should meet on a quarterly basis. The sub committees are to appoint a Chairman who will be the point of contact for that particular sub committee. For all Alliance Management Committee meetings, the sub committee will nominate a representative to attend.

The Purpose of the sub committees are briefly outlined below and may have issues referred to them by the Alliance Management committee for their recommendations.

The sub committees are to minute all meetings and a copy submitted to the Management committee.



Refereeing and Judging (R&J) Sub Committee

The Refereeing and Judging Sub Committee are responsible for everything related to the Amateur Boxing Alliance (England) CIC's Referees and Judges both domestically and internationally. The sub committee are responsible for the development and implementation of the National education program for Referees and Judges including upgrading and appointments for National/International events.

The purpose of the sub committee are to include:

Design, develop and review a standardised syllabus for Referee and Judging courses

Design, develop and review an upgrading system for the Referees and Judges.

To appoint tutors for Referee and Judging courses

To appoint Referees and Judges for National and International Tournaments.

To advise on any disciplinary or complaints involving Referees and Judges as necessary.

Technical and Rules (T&R) Sub Committee

The Technical and Rules sub committee are responsible for maintaining/reviewing the current printed rule book and making recommendations for rule changes to the Management Committee as and when required.

The purpose of the sub committee are to include;

The circulation of Addendum's to the current printed rule book.

To review the Technical aspects of Amateur Boxing

To ensure the correct rules are applied to any given tournament.

To advise on any disciplinary or complaints when requested.



Finance, Commercial and PR Sub Committee

This sub committee is responsible for the organisations finances ensuring they are used effectively whilst maintaining accountability. It is also within their responsibility to oversee the reputation of the organisation within the public eye.

The purpose of the sub committee are to include;

General financial oversight

Funding, fund-raising and sales

Financial planning and budgeting

Financial reporting

Banking and Book keeping

Presenting Audited accounts to the AGM

Liaising with the bank, the Auditors and any other financial institutions on behalf of the Alliance.

Promoting understanding and support for the Alliance by all means available.

Championships Sub Committee

The Championships Sub Committee are responsible for all matters relating to the forward planning and management of domestic championships.

The purpose of the sub committee are to include;

The Championship calendar

The circulation of Championship entry forms and conditions of entry

Any and all Championship draws

Certificate of Achievement

Regional rotation of championship venues



To receive all complaints/referrals on Child protection matters and act accordingly

Disciplinary Sub Committee

The Disciplinary Sub committee are responsible for all complaints and referrals (other than matters relating to Child protection). The sub committee may impose sanctions against any member or club as set out within the Disciplinary and complaints policies and procedures.

The purpose of the sub committee are to include;

To design, develop and review an enforceable code of conduct for clubs and members

To design, develop and review the complaints policy and procedure

To design, develop and review the Disciplinary policy and procedure

To receive all complaints and referrals and follow due process as outlined in the policies and procedures.

Selection Sub Committee

The Selection sub committee are responsible for selecting a National team based on current domestic championship winners/finalists to represent the Alliance in International tournaments.

The purpose of the sub committee are to include;

To select a National team of boxers to compete in an international tournament

To establish and develop points of contact for future international tournaments

To produce itemised costing for all international tournaments to the Alliance Management committee to obtain approval prior to confirming participation abroad or at home

To compile a list of counties/Clubs/contacts for circulation to the member clubs for International club competition.
